

## AUTHORIZING RESOLUTION

A regular meeting of the Sleepy Hollow Local Development Corporation was convened on October 16, 2024 at 7:00 p.m.

The following resolution was duly offered and seconded, to wit:

RESOLUTION OF THE SLEEPY HOLLOW LOCAL DEVELOPMENT CORPORATION (i) ACCEPTING THE CORPORATION AUDIT FOR FISCAL YEAR 2024 (JUNE 1, 2023, THROUGH MAY 31, 2024), AND (ii) AUTHORIZING THE CORPORATION TO PREPARE AN ANNUAL REPORT FOR SAME.

**WHEREAS**, the Sleepy Hollow Local Development Corporation (the “Corporation”) is a not-for-profit local development corporation duly established under Section 1411 of the Not-for-Profit Corporation Law of the State of New York and a “local authority” under Section 2 of the Public Authorities Law of the State of New York (the “PAL”), created pursuant to a Certificate of Incorporation filed on September 18, 2014 for the charitable and public purposes of relieving and reducing unemployment, promoting and providing for additional and maximum employment, improving and maintaining job opportunities, lessening the burdens of government and acting in the public interest; and

**WHEREAS**, the Board of Directors of the Corporation (“Board”) has reviewed the independent auditor's report of the Corporation for fiscal year 2024 (June 1, 2023, through May 31, 2024), as prepared and presented by EFPR Group, CPAs, PLLC (“Auditor”); and

**WHEREAS**, the Board also desires to file the annual report of the Corporation with all appropriate parties; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE SLEEPY HOLLOW LOCAL DEVELOPMENT CORPORATION AS FOLLOWS:

Section 1. The Board has reviewed the independent auditor's report of the Corporation for fiscal year 2024, as prepared and presented by the Auditor, and upon the recommendation of the Audit and Finance Committee hereby approves and accepts such report.

Section 2. Pursuant to PAAA and PARA, the Board hereby authorizes the Corporation to prepare the annual report of the Corporation for fiscal year 2024 and to file the same with (i) the New York State Authorities Budget Office via the Public Authorities Reporting Information System, and (ii) the chief administrative officer, the Village Manager, Village Treasurer and the Mayor of the Village of Sleepy Hollow.

Section 3. The Corporation is hereby authorized to do all things necessary and/or appropriate for the accomplishment of the purposes of this resolution, and all acts heretofore taken by the Corporation with respect to such activities are hereby approved, ratified and confirmed.

Section 4. This resolution shall take effect immediately.
